Legrand signs share buyback agreement

As part of its share buyback program¹, and under the authorization granted by the Ordinary and Extraordinary General Meeting of Shareholders of May 31, 2023², Legrand today announced the signing of a contract with an investment services provider to implement a third tranche for up to €90m.

The purchase period agreement is expected to begin on September 15, 2023 and end on or before October 31, 2023. Those shares will be cancelled.
